



**GLOBAL TENDER FOR APPOINTMENT OF CONSULTANT FOR PREPARATION OF DETAILED PROJECT REPORT (DPR) FOR ZAMBEZE (4695C) AND TETE EAST (7521C) COAL PROJECT TO ICVL MOZAMBIQUE**

**Dear Sir / Madam,**

You are hereby invited to submit your quotation for appointment of consultant for Preparation of Detailed Project Reports (DPR) for Zambeze (4695C) and Tete East (7521C) Coal Project separately as per attached Scope of Work.

Your proposal shall inter alia cover the following:

**1. Price:** Prices should be firm and fixed without any variation factor/adjustment and valid for acceptance for a period of 120 days from the due date of tender opening. Price in **Meticais** including VAT and all applicable taxes. Note that if prices are quoted in a currency other than Meticais, the same will be converted to Meticais by applying the buyer exchange rate published by Central Bank of Mozambique as on the last date of submission of the proposal.

**2. Service:**

Service period quoted should be **definite and guaranteed**. The service will be counted from the date of placement of the order.

Service is required for a period of six (6) months as from the date of Letter Of Intent for Zambeze (4695C).

Service is required for a period of six (6) months as from the date of sharing of geological report for Tete East (7521C) from ICVL.

**3. Penalty:** ICVL shall have the right to levy penalty for delay in offering the service. Failure to offer the service in time will attract penalty @ 0.5 % of the basic order value for each week or part thereof but not exceeding 5% of the order value.

**4. EMD:** The Bid must be accompanied with an Earnest Money Deposit (Hereinafter “EMD”) of USD 5,000.00 (Five Thousand United States Dollars) in the form of Bank Guarantee or Bank Transfer. In the case of Electronic Transfer, each Bid should be accompanied by proof of transfer (SWIFT, etc.) of the Earnest Money of USD 5,000.00 (Five Thousand United States Dollars) to the bank account of MBL given bellow:

**Bidders shall submit the following documents:**

1. Certificate of registration as legal entity or individual trader, for legal entities and individuals, respectively;
2. Articles of association (as published in the Official Gazette) or a copy of the identification document (ID for nationals and Dire for foreigners), for legal entities and individuals, respectively;
3. Declaration stating that there is no foreclosure or a bankruptcy petition which may affect his financial capacity, for individuals or legal entities respectively;
4. Balance sheets and financial statements of the last three fiscal years, as submitted in terms of the law;
5. Business Licence or equivalent document issued by the competent authorities; and
6. Evidence of Tax Registration and Declaration of the Commencement of Activities.

**5. Eligibility Criteria:**

- a) The bidder should have technical capability and proven experience of minimum 5 projects in last 5 years for formulation of Feasibility Reports/Project Reports/DPR for Coal Mining Projects of capacity not less than 5 MTPA.
- b) The bidder should have technical capability and proven experience of minimum 5 projects in last 5 years for formulation of Feasibility Reports/Project Reports/DPR for washery projects of 3 MTPA capacity or more on BOO/ BOM basis.
- c) The bidder should have technical capability and proven experience of minimum 5 years projects in last 5 years for formulation of Feasibility Reports/Project Reports/DPR for CHP projects of 5 MTPA capacity on BOO/BOM basis.
- d) The bidder should have on-roll technical professionals with relevant experience in Mine Planning, CHP design and Washery design (CPP), for at least last 5 years.
- e) The bidder should have average turnover of at least 20 million USD for last 3 years.

**6. Payment Terms:** The payments will be made on the basis of mutually agreed milestones/deliverables. (Payment shall be release within 30 days after receipt of correct invoice).

**7. Validity of the proposal:** 120 days minimum
